Product Description

The BevReady Pure 0.2μ provides sterile filtration and microbial stabilization to maintain product integrity. The hydrophilic asymmetric membrane extends filter life and allows for integrity testing to ensure product quality. Moreover, the thermal welded design leads to increased durability and low levels of extractables.

Quality Test

All filter cartridges are integrity tested to verify compliance with established quality and design specifications and to assure consistent and reliable performance.

The traceability of each filter cartridge, according to EC/1935/2004, is provided by serial number.

All BevReady Pure 0.2μ cartridges are completely staged, assembled, tested, and packaged in ISO 14644-1 Class 7 clean room facility whose Quality Management System is approved by an accredited registering body to the appropriate ISO9001 Quality Systems Standard.

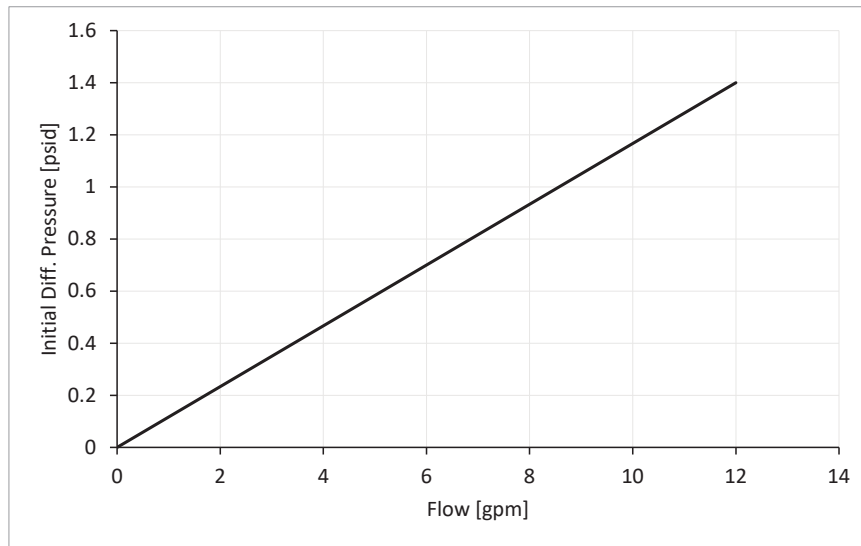
